

Privacy Policy

- Jaunt Planners values the privacy and trust of its customers and website visitors. This Privacy Policy explains how personal information is collected, used, stored, and protected when users engage with services such as visa assistance, itinerary planning, flight booking support, hotel reservation guidance, and travel consultation through jauntplanners.com.
